(A) Inadequate hot holding of PHF/TCS food.

PRIORITY

Recommended Resolution - Except for roasts, which can be held at 130°F after cooking, potentially hazardous/time-temperature control for safety food that is being held hot must be held at 135°F or above. This deficiency must be corrected within a maximum of 3 days

Observations and Corrective Actions - Steam table had temperatures below 135

(A & B) Cold time/temperature control for safety food not adequately temperature controlled.

PRIORITY

Recommended Resolution - Except for raw shell eggs, which can be held at 45°F, potentially hazardous/time-temperature control for safety food that is being held cold must be held at 41°F or lower. This deficiency must be corrected within a maximum of 3 days

Observations and Corrective Actions - 2 door cooler in back prep area has temperatures above 41, digital thermometer is reading 47-52 during inspection; recommend servicing. Even during defrost cycle food temperatures should not rise to 43-45 degrees.

(All) Poisonous or toxic materials stored improperly.

PRIORITY

Corrected on site

Recommended Resolution - Poisonous or toxic materials shall be stored so they can not contaminate food, equipment, utensils, linens, and single-service and single-use articles by: separating the poisonous or toxic materials by spacing or partitioning; and locating the poisonous or toxic materials in an area that is not above food, equipment, utensils, linens, and single-service or single-use articles. This deficiency must be corrected within a maximum of 3 days

Observations and Corrective Actions - Ice cleaners stored on top of ice machine; COS=moved when notified

(A,B) Hair restraints not worn where required.

Recommended Resolution - Food employees shall wear hair restraints such as hats, hair coverings or nets, beard restraints, and clothing that covers body hair, that are designed and worn to effectively keep their hair from contacting exposed food; clean equipment, utensils, and linens; and unwrapped single-service and single-use articles. This deficiency must be corrected within a maximum of 90 days.

Observations and Corrective Actions - Observed employee with hair longer than shoulder length not restrained

(All) Kitchenware and tableware not stored (handles in one-direction) or handled to prevent contamination.

Recommended Resolution - Single-service and single-use articles and cleaned and sanitized utensils shall be handled, displayed, and dispensed so that contamination of food and lip contact surfaces is prevented. Knives, forks, and spoons that are not prewrapped shall be presented so that only the handles are touched by employees and by consumers if consumer self-service is provided. This deficiency must be corrected within a maximum of 90 days.

Observations and Corrective Actions - Single service forks and spoons are stored with handles in both directions for self service, make sure handles are store in the same direction to prevent contamination.

Jamaican Jerk Chicken – Mobile Food Service (Pablo)

(A) Cross-contamination of raw animal products that require a lower cook temperature with those that require a higher cooking temperature not adequately prevented in storage, preparation, holding, and display.

PRIORITY

Corrected on site

Recommended Resolution - Raw animal products must be stored according to final minimum required cooking temperature with items requiring higher temperatures stored away from or below those requiring lower temperatures. This deficiency must be corrected within 3 days.

Observations and Corrective Actions - Raw chicken stored above raw brats; COS=raw brats moved above raw chicken

(A) Inadequate hot holding of PHF/TCS food.

PRIORITY

Corrected on site

Recommended Resolution - Except for roasts, which can be held at 130°F after cooking, potentially hazardous/time-temperature control for safety food that is being held hot must be held at 135°F or above. This deficiency must be corrected within a maximum of 3 days

Observations and Corrective Actions - Observed chicken on stove top at 66F, discussed chicken needs to be above 135F to hot hold, can't hold chicken in the temperature danger zone where bacteria grows; COS=Moved chicken to flat top to reheat to 165 and hold for hot hold

Pot of rice on back deck with no temperature control at 80F, most likely used for mixed rice with beans in hot hold in 2 locations-discussed rice needs to be held above 135, very high potential for bacteria to grow in rice held at this temperature. Rice was discarded.

(A & B) Cold time/temperature control for safety food not adequately temperature controlled.

PRIORITY

Recommended Resolution - Except for raw shell eggs, which can be held at 45°F, potentially hazardous/time-temperature control for safety food that is being held cold must be held at 41°F or lower. This deficiency must be corrected within a maximum of 3 days

Observations and Corrective Actions - Prep cooler is not holding safe temperatures-observed temperatures above 41F; thermometer is reading above 50F; Moved items to ice bath

(B) Handwashing sink used for purposes other than handwashing.

PRIORITY FOUNDATION

Recommended Resolution - A handwashing sink may not be used for purposes other than handwashing. This deficiency must be corrected within a maximum of 10 days.

Observations and Corrective Actions - Dirty utensils are stored in the handsink

(All) Ready-to-eat PHF/TCS food improperly date marked.

PRIORITY FOUNDATION

Recommended Resolution - Ready-to-eat, potentially hazardous/time-temperature control for safety food, prepared and held in a food establishment for more than 24 hours shall be clearly marked to indicate the date or day by which the food shall be consumed on the premises, sold, or discarded when held at a temperature of 5°C (41°F) or less for a maximum of 7 days. The day of preparation is counted as Day 1. The day or date marked by the food establishment may not exceed a manufacturer's use-by date. This deficiency must be corrected within a maximum of 10 days.

Observations and Corrective Actions - Most items are date marked 6/7 or 6/4, today is 6/21. Need to consistently date mark items in trailer.

(All) Frozen foods not maintained frozen.

Observations and Corrective Actions - Garbage can is outside of mobile, need to have one inside for papertowels and all other waste generated from the mobile.

(A-E) Outer openings not protected against the entry of insects and/or rodents.

Recommended Resolution - Outer openings of a food establishment shall be protected against the entry of insects and rodents by: filling or closing holes and other gaps along floors, walls, and ceilings; closed, tight-fitting windows; and solid, self-closing, tight-fitting doors. This deficiency must be corrected within a maximum of 90 days.
